Dear Campus Community,

As you know, Dr. Darron Turner retired from his position as Senior Advisor to the Chancellor and Chief Inclusion Officer in December 2020. Ms. Aisha Torrey-Sawyer was appointed in January as interim Senior Advisor to the Chancellor and Chief Inclusion Officer, and in her role she is continuing to implement diversity, equity, and inclusion (DEI) priorities as part of the overarching DEI strategic plan. With that context, I am pleased to share with you that a national search for a new Senior Advisor to the Chancellor and Chief Inclusion Officer is underway with the goal of announcing the new hire in Fall 2021.

Texas Christian University has engaged the executive search firm WittKieffer, who will help recruit and assess candidates for the position. We have established a timeframe with next steps. The process will begin in the coming weeks with outreach meetings, when Dr. Nguyen and the Wittkieffer team will hold information-gathering sessions with stakeholders. The Search Committee will vet applicants and interview semi-finalists during the summer months. Thereafter, finalists for the position will be invited to visit campus in August and September so that we can garner more input from the TCU community during meetings and open forums.

TCU has the opportunity to build on the DEI successes of the past few years and advance the strategic plan and priorities for a more inclusive campus.
